#### AAU — CULTURE OF SAFETY

As the Amateur Athletic Union (AAU) enters into its 124th season, the organization has announced a *Culture of Safety* initiative. AAU is implementing a series of historic child protection measures, in order to insure the safety of youth athletes.

These policy changes have followed a six-month review process conducted in the form of two AAU-commissioned task forces, which were focused upon child protection and adult volunteer screening. One such policy change will be the mandatory background screenings of all staff, coaches and volunteers. These screenings will begin for this coming season (Sept. 1, 2012 — Aug. 31, 2013). In the past, AAU had conducted random screenings and/or when questions had arisen concerning an individuals conduct.

AAU has contracted with *Lexis-Nexis Risk Solutions* to conduct these background screenings. The company is generally considered to be the gold-standard of the industry and is already responsible for conducting over 5.5 million background checks on behalf of other non-profit organizations such as: the Boys & Girls Clubs, Little League Baseball and the Boy Scouts.

AAU membership fees will be increasing by an additional \$2, in order to defray the costs of these background screenings.

In addition to the background checks mentioned above, policies will prevent adults from being alone in rooms with youth athletes and will have a zero-tolerance policy concerning hazing. AAU is also creating a child protection manual, in order to guide its members.

#### AAU — POSITIVE COACHING ALLIANCE

AAU coaches are required to participate within the <u>Free</u> online coaching education program, which is administered by the Positive Coaching Alliance. For the 2012-2013 season, any coach who is just arriving at AAU will be required to take **Dual-Coach course Part 1**. Returning AAU coaches who have already taken and passed Part 1 must take **Dual-Coach course Part 2**.

#### USA HOCKEY — SUMMER MEETING

USA Hockey has completed their Summer Meeting in Colorado Springs, which was held from June 6th through 9th. The big concern for Mites and their families around the nation was the proposed change in the definition of the U8 playing surface. Many USAH Districts have already eliminated or limited Mite full-ice hockey. The USAH Board of Directors has voted to:

'Set the standard of the playing surface for games and scrimmages at the 8U age level as either cross-ice or half-ice, or on a surface that is equal to or less than the dimensions of cross-ice or half-ice, beginning with the 2013-14 playing season, with a provision that allows affiliates an opportunity to apply for an exception for a limited number of full ice games or scrimmages.'

Several USA Hockey Districts had already instituted Cross-Ice and/or Half-Ice as their standard playing surface for U8. Obviously, MAHA did so last season. In areas where the District had not mandated a smaller playing surface, many of the state associations have.

It is important to note that USA Hockey has also voted to switch from a 2-year rule-change cycle to a 4-year rule-change cycle. This will mean that the U8 smaller playing surface should remain in effect, at least through the 2016-2017 season.

## MAHA — SUMMER MEETING

Now that USA Hockey has completed their summer meeting, attention will switch to MAHA. They are preparing for their summer meeting, which will take place on July 12-15th.

Of course, many already know that last season MAHA adopted a U8 prohibition on full-ice (as well as Mite Travel), which were to be phased in over the coarse of 2 years. However, apparently in response to the great success of AAU here in Michigan, MAHA has suspended their U8 mandate for this Spring and proposed a substantial reinstatement of Mite full-ice and Mite Travel for the 2012-2013 season.

So now comes the dilemma. <u>Will MAHA actually adopt a single season rule change?</u> Of course, this would mean that Mites would have been whip-sawed from full-ice in 2010-2011, to cross-ice in 2011-2012, to full-ice in 2012-2013 and again back to cross-ice in 2013-2014.

Obviously, AAU Michigan and Hockey Michigan continue to view cross-ice, half-ice and full-ice to be voluntary matters, which should be decided by teams and/or their respective leagues.

#### AAU MICHIGAN - ICE HOCKEY ANNUAL MEETING


The AAU Michigan - Ice Hockey Committee will be hosting its Annual Meeting on Sunday **July 22nd 2012** at **11:00**<sub>am</sub> @ the **Westfield Activity Center** (the Westfield is located at 2700 Westfield in Trenton Michigan).

Each AAU ice hockey club will be permitted to cast one vote on any given issues (only individuals who are listed as a Club Representative possess voting rights for that given club). However, all AAU members are welcome to attend.

Additional notices will be repeated and an agenda will be provided as we approach the date of the meeting. However, initially expect that topics will likely include (but not be limited to):

- a report on the 2011-2012 season and plans for 2012-2013.
- a review of USA Hockey (USAH) and Michigan Amateur Hockey Association (MAHA) changes.
- a review-update of likely; Age Classifications, Division and Team for the 2012-2013 season.
- Plans for State Playoffs in 2013.
- Votes affecting AAU Michigan Ice Hockey; By-Laws, Rules & Regulations, etc.

We would also like to begin forming a State Playoff committee. Hopefully we can utilize our State Championships to continue our theme concept. Last season our Mites State Championship was used as a platform to allow Military Moms United to collect materials and funds to aid our armed forces serving overseas. Hopefully, each Championship can be used to benefit a separate charity.



#### AAU YOUTH LEAGUES ARE FORMING NATIONWIDE

Many of us involved in the creation of the Hockey Michigan full-ice mite alternative were caught by surprise last season, with far greater acceptance and growth then originally expected. Ultimately spreading into 4 nearby states, while seeing 4-5 times as many teams as originally anticipated here in Michigan.

As word travels concerning the moves toward District and National cross-ice mandates, we expect to see continued expansion of AAU programs throughout the summer, which will ultimately provide coast to coast AAU youth teams for the 2012-2013 regular season.

## TROPICAL ELITE JUNIOR LEAGUE

Yet another junior league has been sanctioned by the AAU. Our newest arrival is the Tropical Elite Junior Hockey League (TEHL). The league expects to host 6 teams for the 2012-2013 season, initially operating in central Florida.

Tropical Elite (TEHL <u>www.icefactory.com</u>) joins the Midwest Junior Hockey League (MWJHL <u>www.mwjhl.com</u>) joins the Northeastern Junior Hockey League (NJHL <u>www.thenjhl.com</u>), the Western States Hockey

League (WSHL <u>www.wshl.org</u>). Collectively, these leagues now give AAU junior hockey a coast to coast presence of over 40 teams (and still growing).

Several other junior leagues are considering a switch to the AAU over the summer.



## HELP WANTED @ AAU HOCKEY

Obviously, the AAU Michigan - Ice Hockey Committee was begun in a hurried fashion during 2011-2012. Currently we are working on our By-Laws and a structure needed for moving forward.
