Interstate 78 Westbound

Exit 15, at top of exit continue straight through traffic light. The Holiday Inn Select is ¼ mile on the left.

Interstate 78 Eastbound

Take Exit 15, bear right off exit to traffic light. Turn left. The Holiday Inn Select is ¼ mile on the left.
