Therefore all schools participating at the 2012 AAU Tae Kwon Do Qualifier are required to order the appropriate number of foot protectors for their team before March 24th 2012.**

**This device (DAEDO E-HOGU) has been licensed by WTF and it is the only WTF approved PSS in the world and this event will be utilizing this system. (This year we will make exhibition fights for those that don't have anyone in their division.**
