Competitors Attire

For Kobudo and Kata:

- White gi/uniform, no piping or borders.
- White, green, brown or black belt for the category you have entered.
- One patch on the left side of jacket.
- Corrective lenses including glasses are allowed.

For Kumite:

- White gi/uniform, no rolled sleeves on arms or legs, one patch on left side of jacket.
- No glasses are permitted.
- White helmet for competitors 18 years and below. Due to questionable design, face shields will NOT be permitted.
- Mouthpiece and vinyl/Naugahyde mitts required for all ages.
- Groin cups are required for males; chest protectors are optional for females.
- Shin guards are optional and permitted. Foot guards are not permitted.

Blue blazer, white shirt, red or maroon tie (preferably AAU logo), grey slacks, black socks and shoes.
