- 2) **AAU National Team Trial Competitors** At least one team athlete (& paid team coach) must have competed in the 2014 AAU T&T Junior Olympic Games which were held in Des Moines, Iowa.
- 3) **Stars of Tomorrow National Team Trial Competitors** At least one team athlete (& paid team coach) must have competed in the 2014 T&T Junior Olympic Games which were held in Houston, Texas.
- 4) **Super Sunshine Invitational** All T&T athletes with a current AAU Extended Benefit Coverage Membership are welcome.

EQUIPMENT: Euro Tramps, Double-Mini, & Rod Floors

Athletes **may** only enter **each event once**. For example, can enter one Tumbling event, one Trampoline event, and one Double-Mini event; however, they cannot enter Team Trial Tumbling and Invitational Tumbling.

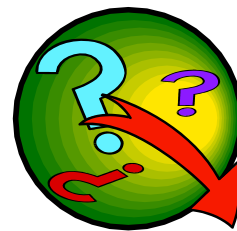
