\*Athletes who are still eighteen (18) years of age through the final day of competition in any AAU National Youth Championship meet shall be eligible to compete in the Young Women's/Men's age

division.

**ELIGIBILITY:** 

Open to all current 2009 AAU Members. No qualification required. NOTE: Competitors are responsible for determining whether competing in this meet will disqualify them from competing in events sponsored by their State High School Activities Athletics Association.

**FIELD EVENTS:** 

Approved implements will be provided. Competitors' own Implements may be used with Meet Director's approval. These implements will be weighed-in and will become part of the equipment pool and will be used for the duration of the meet. Only Indoor Shots will be used.

RELAYS:

All Relay Teams must present a current 2009 AAU Club Membership, Relay teams must wear identical uniforms. Club membership will be available for purchase onsite.

AWARDS:

AAU National Championship medals will be presented for the first through sixth place. For relay events, medals will be awarded to each team member placing first through third.

AAU MEMBERSHIP:

All competing athletes must have a current 2009 AAU membership. No athlete will be allowed to participate without AA membership. To obtain a current AAU card, registration membership is available on-line www.aausports.org.

PACKET PICKUP:

Packet Pickup at Radisson Friday, February 21st., 8:00 am – 12:00 pm. On-site packet pickup will take place at Merrillville High School on Friday from 4:00 pm – 9:00 pm as well as during competition hours Saturday and Sunday.

ADMISSION:

Admission fee of \$5 per day. Coaches and none athletes who do not have proof of their 2009 AAU Membership will be required to purchase tickets.

HOUSING:

In the Long Jump and Shot Put there will be no trials, each athlete will have four attempts. The 800 meter run, 1500 meter run, 3000 meter run, 1500 and 3000 meter Race Walk will all be timed finals. These races will be waterfall starts and time will determine place.
