Third and final day of pool play. Following the completion of pool play, a team representative must receive and sign for a bracket schedule. Failure to pick up the bracket schedule may result in a game forfeit.

Additional Information--

The home team will wear light jerseys and are listed first in pool play and on top in bracket play.

All bench personnel must adhere to the Coaches Dress Code by wearing a shirt with collar, long pants or dress shorts/skirts, and closed toe shoes. No hats may be worn while on the bench or during Opening Ceremonies. Each violation to the bench rule will result in a technical foul (administrative, not charged to the coach).

Example: If a person is charged with the technical foul then he/she must leave the bench area until his/her attire meets the code.
