1) ELITE: THREE PICK-UP PLAYERS ALLOWED.

2) COMPETITIVE: THE ROSTER IS FROZEN AT THE QUALIFYING REGIONAL. ALL ATHLETES MUST HAVE PLAYED TO BE ELIGIBLE, FOR THAT ROSTER, OUT OF A SPECIFIC REGIONAL OR QUALIFIER. AFTER POOL PLAY, ALL TEAMS ADVANCE TO THE BRACKETED PLAYOFFS.

\*TEAMS WILL BE PLACED INTO THE APPROPRIATE LEVEL BASED ON THE STRENGTH OF THE TEAM AND THE STRENGTH OF THE COMPETITION AT THE REGIONAL QUALIFIER. TEAMS CAN REQUEST TO MOVE TO A HIGHER LEVEL.

**COMPETITION: FORMAT OF PLAY:** A POOL PLAY SYSTEM WILL BE USED. THERE WILL BE AN EVEN NUMBER OF TEAMS (IF POSSIBLE) IN EACH POOL. **EACH TEAM WILL BE GUARANTEED A MINIMUM OF FOUR GAMES.** MANY TEAMS WILL RECEIVE 5-7 GAMES. ALL TEAMS WILL RECEIVE 2 POINTS FOR A WIN AND 1 POINT FOR A TIE. **GAME FORMAT:** A TWO MINUTE WARM-UP IS ALLOWED BEFORE EACH GAME. THERE WILL BE 18 MINUTE HALVES WITH A REST PERIOD OF ONE MINUTE BETWEEN HALVES. THE CLOCK WILL STOP IN THE LAST MINUTE WITH A SCORE WITHIN ONE GOAL OR A TIE. GAMES ENDING IN A TIE DURING POOL PLAY WILL END IN A TIE AND EACH TEAM WILL BE AWARDED 1 POINT IN THEIR POOL PLAY STANDINGS. ONLY DURING THE BRACKETED PLAYOFFS WILL A GAME GO INTO A SUDDEN DEATH OVERTIME PERIOD.

**TIE-BREAKERS: FIRST:** POOL PLAY TIEBREAKERS WILL BE DETERMINED BY HEAD TO HEAD (2 TEAMS ONLY).

SECOND: TIES WILL BE BROKEN BY COMPARING GOALS AGAINST.

# RULE-SHEET

- LENGTH OF GAME: 2 HALVES, 20 MINUTES IN DURATION EACH (RUNNING TIME). STOP CLOCK IN THE LAST MINUTE WHEN THE SCORE IS WITHIN 1 GOAL OR TIED.
- TIME-OUTS: EACH TEAM IS PERMITTED ONE TIME-OUT PER GAME, ONE MINUTE IN LENGTH. THE GAME CLOCK SHALL STOP DURING A TIME-OUT.
- MERCY RULE: SHOULD A TEAM SCORE ENOUGH GOALS TO MAKE AN EIGHT (8) GOAL DIFFERENTIAL BETWEEN THEM AND THEIR OPPONENTS, THE GAME SHALL BE ENDED, AND THE TEAM SCORING EIGHT MORE GOALS THAN THEIR OPPONENT SHALL BE AWARDED A VICTORY.
- 3-PENALTY RULE: ANY PLAYER THAT RECEIVES 3 PENALTIES OF ANY KIND IN A SINGLE GAME, HE/SHE IS TO BE RULED OFF THE FLOOR FOR THE REMAINDER OF THE GAME.
- PENALTIES: MINOR PENALTIES-2 MINUTES, MAJOR PENALTIES-5 MINUTES, MISCONDUCT PENALTY- 10 MINUTES
- MATCH PENALTY: 5 MINUTES TO BE SERVED PLUS PLAYER SHALL BE RULED OFF THE FLOOR FOR THE REMAINDER OF THE GAME.
- GAME EJECTION: PLAYER SHALL BE RULED OFF THE FLOOR FOR THE REMAINDER OF THE GAME.
- GAME MISCONDUCT: CARRIES AN AUTOMATIC 1 GAME SUSPENSION.
- STARTING LINEUP: A TEAM MUST HAVE A GOALIE AND FOUR PLAYERS TO START A GAME.
- START OF GAME: PLAYERS WILL START THE GAME DEFENDING THE ZONE OPPOSITE THEIR PLAYER BENCH.
- FACE OFFS: ONCE A TEAM IS IN FACE-OFF POSITION, THE PUCK CAN BE PUT INTO PLAY WITHIN THREE SECONDS.
- FACE OFF SPOTS: ONLY RECOGNIZE FOUR END ZONE FACE OFF SPOTS AND CENTER DOT. ALL FACE-OFFS TAKE PLACE ON ONE OF THESE DOTS, OR LOCATION OF LAST PLAYED.
- TIED GAMES: GAMES SHALL END IN A TIE IF NO WINNER. MUST BE DETERMINED (ROUND ROBIN GAMES). IF A WINNER MUST BE DETERMINED (PLAYOFF GAMES), THE LENGTH OF A SUDDEN DEATH OVERTIME PERIOD WILL BE DETERMINED BY THE LENGTH OF THE PREVIOUS REGULATION TIME PERIOD AND CONTINUOUS PERIODS THEREAFTER UNTIL A WINNER HAS BEEN DETERMINED. TEAMS WILL SWITCH ENDS FOR EACH AND EVERY OVERTIME PERIOD.
- PLAYERS/PENALTY BENCH: EACH TEAM IS RESTRICTED TO 3 TEAM OFFICIALS ON THE BENCH. NON-UNIFORMED PLAYERS ARE PROHIBITED FROM OCCUPYING THE PLAYERS/PENALTY BENCH.
- CHANGE OF PLAYERS: PERMITTED DURING A STOPPAGE OF PLAY AT ALL TIMES.
- ROUGHING: A MINOR OR DOUBLE MINOR PENALTY MAY BE IMPOSED ON ANY PLAYER FOR UNNECESSARY ROUGHNESS.
- BUTT-ENDING/SPEARING: ATTEMPT: DOUBLE MINOR PENALTY. MAKING CONTACT: MAJOR PENALTY PLUS GAME MISCONDUCT.
- CHECKING FROM BEHIND: A MAJOR PENALTY AND AUTOMATIC GAME MISCONDUCT MUST BE ASSESSED FOR CHECKING FROM BEHIND.

# RULE-SHEET CONTINUED

- FIGHTING: MAJOR PENALTY PLUS GAME MISCONDUCT; ADDITIONAL MINOR PENALTY FOR INSTIGATOR. ANY PLAYER REMOVING SWEATER BEFORE OR DURING FIGHT AUTOMATICALLY ASSESSED INSTIGATOR. ANY PLAYER DROPPING GLOVES IN AGGRESSIVE OR THREATENING MANNER RECEIVES A GAME MISCONDUCT.
- HIGH STICKING: A HIGH STICKING VIOLATION (NON-PENALTY) RESULTS IN A FACE-OFF AT CENTER OR SPORT LAST PLAYED IF IN THE DEFENSIVE ZONE. IF A TEAM IS "SHORT-HANDED", AND THE OPPOSITION IS CHARGED WITH A HIGH STICKING VIOLATION, THE FACE-OFF IS TO TAKE PLACE AT THE END ZONE FACE OFF SPOT OF THE OFFENDING TEAM.
- DISPLACING GOAL POST: INTENTIONAL IN THE LAST 2 MINUTES OR IN OT RESULTS IN A PENALTY SHOT FOR NON-OFFENDING TEAM.
- BROKEN STICK: A GOALTENDER CAN PLAY WITH BROKEN STICK UNTIL NEXT STOPPAGE OF PLAY.
- GOALS: A GOAL SHALL NOT BE ALLOWED IF THE PUCK HAS BEEN KICKED, THROWN OR OTHERWISE DELIBERATELY DIRECTED INTO THE GOAL BY ANY MEANS OTHER THAN A STICK.
- COINCIDENTAL PENALTIES: ALL COINCIDENTAL MINOR PENALTIES ARE TO BE SERVED WITHOUT IMMEDIATE SUBSTITUTION, UNLESS ONE OR BOTH TEAMS HAVE BEEN REDUCED TO TWO PLAYERS ON THE FLOOR. IN THIS SITUATION, THE PLAYERS ASSESSED THE COINCIDENTAL PENALTIES ARE TO SERVE THEIR PENALTIES IN THEIR ENTIRETY AND MUST WAIT FOR THE NEXT STOPPAGE OF PLAY TO RETURN. IMMEDIATE SUBSTITUTIONS ARE TO BE MADE FOR THESE PLAYERS.
- COINCIDENTAL PENALTIES: WHEN A MAJOR PENALTY AND A MINOR PENALTY ARE IMPOSED UPON PLAYERS OF DIFFERENT TEAMS DURING THE SAME STOPPAGE OF PLAY AND THE MAJOR PENALTY CANNOT BE SERVED IN ITS ENTIRETY (DURING THE LAST FIVE MINUTES OF THE SECOND HALF OR AT ANY TIME DURING OVERTIME), THE DIFFERENCE IN PENALTY TIME WILL BE GIN IMMEDIATELY, BEING SERVED AS A MAJOR PENALTY BY A PLAYER OF THE OFFENDING TEAM, AND THE PENALIZED PLAYERS WILL RETURN TO PLAY AT FIRST WHISTLE AFTER THE EXPIRATION OF THEIR RESPECTIVE PENALTIES. THIS ALSO INCLUDES THE SITUATION WHERE A PLAYER IS ASSESSED A MINOR, AND HIS OPPONENT IS ASSESSED A DOUBLE MINOR WITH LESS THAN FOUR MINUTES TO PLAY IN THE 2ND HALF OR AT ANYTIME DURING OVERTIME.
- DELAYED PENALTIES: IF WHEN A TEAM IS "SHORT-HANDED" BY REASON OF ONE OR MORE MINOR OR BENCH MINOR PENALTIES THE REFEREE SIGNALS A FURTHER MINOR PENALTY AGAINST THE "SHORT-HANDED" TEAM A GOAL IS SCORED BY THE NON-OFFENDING SIDE BEFORE THE WHISTLE IS BLOWN THEN THE DELAYED PENALTY SHALL BE SERVED AND THE FIRST OF THE MINOR PENALTIES ALREADY BEING SERVED SHALL AUTOMATICALLY TERMINATE.
