❶. If your athletes want to try out for the 2004 A.A.U. National Team, your club must compete in the 2003 A.A.U. T&T Junior Olympic Competition.

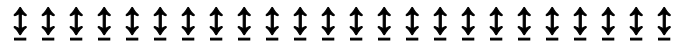
